**PREDMET: Izveštaj sa 60.Konferencije Međunarodne unije advokata**

Poštovani članovi Upravnog odbora Advokatske komore Vojvodine,

u periodu od 28. oktobra do 1.novembra 2016.godine, u Budimpešti, Republika Mađarska, održan je 60.Kongres Međunarodne unije advokata, kom su prisustvovali i predstavnici Advokatske komore Vojvodine, advokati Goran Stanivuković, Boško Kaćanski, Jelena Tešanović i Ivana Kapor.

Predstavnici Advokatske komore Vojvodine su doputovali u petak uveče i prisustvovali predavanjima predavanjima i diskusijama na temu Compliance, Međunarodna arbitraža, Kompanijsko pravo i spajanje i pripajanje privrednih društava a naročito advokatskih kancelarija.
